The Fund is aiming to achieve income in come from a short-term, or less than one year, securities and other money market instruments.

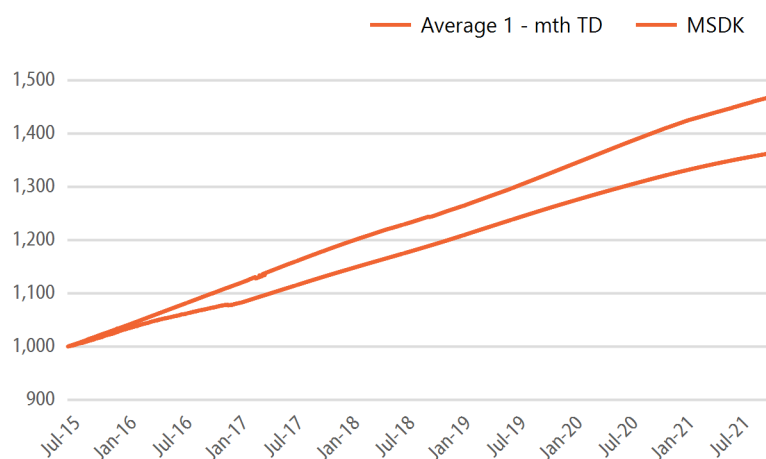
Investment Strategy
